
HARRIS COUNTY MUNICIPAL UTILITY DISTRICT NO. 383

The Board of Directors of Harris County Municipal Utility District No. 383 will hold a regular meeting on **Wednesday, September 6, 2023, at 12:00 p.m.**, at the offices of Allen Boone Humphries Robinson LLP, 3200 Southwest Freeway, Suite 2400, Pecos Conference Room, Houston, Texas, to discuss and, if appropriate, act upon the following items:

1. Receive comments from the public.
2. CONSENT AGENDA: The following items are considered routine by the Board and will be enacted by one motion. No separate discussion will occur on these items unless a Board member so requests, in which event the item will be removed and placed on the Non-Consent Agenda.
 - a. Approve minutes.
 - b. Approve Annual Report and authorize filing of same in accordance with the District's Continuing Disclosure of Information Agreement and as required by SEC Rule 15c2-12.
 - c. Annual Review of Procedures for Continuing Disclosure Compliance.
 - d. Development in the District and elsewhere in Gleannloch Farms.
 - e. Tax assessment and collection matters, including delinquent tax collections and payment of tax bills.
 - f. Financial and bookkeeping matters, including payment of bills, review of investments, and budget comparison.
 - g. Garbage and recycling matters.
 - h. Operation of District facilities, including:
 - i. billings, repairs and maintenance, customer correspondence, and message language on water bills;
 - ii. North Harris County Regional Water Authority matters; and
 - iii. sanitary sewer video inspection program and repairs.
 - i. District park matters, community improvement projects, and related coordination with community association.
 - j. Channel and pond maintenance, including detention and drainage facilities report and proposals for work.
 - k. Storm Water Management Plan matters, including proposals for work.
 - l. District website and communication matters.

 - b. Engineering matters, including:
 - i. authorize design of District facilities;
 - ii. approve plans and specifications and authorize advertisement for bids for construction projects, including:
 - aa. waterline loop; and

- bb. third water well;
- iii. review bids and award contracts;
- iv. approve pay estimates, change orders, and final acceptance as appropriate, for construction projects;
- v. update on application for renewal of Texas Pollutant Discharge Elimination System Permit;
- vi. deeds, easements, execution of plats, consents to encroachment requests for annexation and/or service, utility commitment letters, and wastewater service contracts;
- vii. capital improvement plan, including project funding;
- viii. update on District drainage matters and, if appropriate, authorize District engineer to conduct drainage study;
- ix. authorize engineer to prepare bond application; and
- x. other engineering matters.
- c. Additional tax matters, including:
 - i. discuss 2023 tax rate, set public hearing date, and authorize notice of public hearing regarding adoption of tax rate.
- d. Additional financial and bookkeeping matters.
- e. Additional operating matters, including:
 - i. hearing on termination of water and sewer service to delinquent customers and authorize termination of service.
- f. Reports from Directors and District consultants on District matters.
- g. Attorney's report.
